1. In RFP # 08-035, any reference to 2008 Certificate To Do Business With Genesee County should read as follows:

2. Section 2 of the Standard Proposed Contract (RFP #08-035, Attachment 1, page 18) should read as follows:

“2. Term

2.1 Initial Term

The initial term of this Agreement is effective upon approval by the Genesee County Board of Commissioners (the “Board”) and shall be effective for **three (3) years** (the “Initial Term”).

2.2 Extension Terms

The Board has the option to extend this Agreement for up to **two (2)** additional one year terms (the “Extension Terms”).”

ATTACHMENT 1

QUESTIONS AND ANSWERS RFP #08-035 ON-LINE LEGAL RESEARCH SYSTEM AND SERVICES

- Q1. How much does the County now pay for its online legal research subscription? What online content does the County now access on a flat-rate, unlimited basis?**
- A1. Genesee County pays \$7,159 monthly (\$85,908 annually) for all county users (approximately 135). The on-line content accessed by the County can be seen in Attachment 2.
- Q2. If a bidder submits with the proposal a current Certificate to do Business with Genesee County, must the bidder also complete and submit with the proposal a completed Model Equity and Diversity Plan in Attachment 2?**
- A2. Given that proposals will be received on December 30th, it is more appropriate for proposers to obtain a 2009 Certificate To Do Business With Genesee County. In the event a proposer has a current certificate, the proposer may obtain a 2009 Certificate by completing a renewal application, or by completing the Model Equity and Diversity Plan (RFP 08-035, Attachment 2). In any case, a copy of the completed Renewal Application or Model Equity & Diversity Plan should be submitted with your proposal. The renewal application can be obtained from the Genesee County Equity and Diversity website (www.co.genesee.mi.us/oed/index.htm).
- Q3. On page 5 of the RFP, you state that pricing shall be firm for five years; however on pg. 18, the Professional Services Contract defines term as being up to four years combined. Please clarify.**
- A3. Please see item #2 of this addendum for clarification.
- Q4. On page 19, sec. 8 Reporting Requirements refers to those listed in Exhibit B, which is itself void of any reports. Could you specify what types of reporting will be required.**
- A4. The County anticipates that usage reports may be required of the Contractor. Reports should depict the number of transactions, department and module/service used.
