**REQUEST FOR QUALIFICATIONS (RFQ) #09-008
PROFESSIONAL SURVEYING SERVICES FOR THE GENESEE
COUNTY MONUMENTATION & REMONUMENATION PROGRAM**

1. In RFQ #09-008, Section 4., page 9, should read, in part, as follows:

“Issue Addendum (if applicable) May 22, 2009”
2. In RFQ #09-008, Section 6. Scope of Services, page 12, item #8, should read as follows:

“Completion Date: Work may begin immediately after contract **execution**. All field work must be completed no later than December 10, 2009 and all office activities completed no later than December 20, 2009. Contractor must perform all services in a professional and timely manner acceptable to the **Peer Review Group** and the County Representative to insure that grant funds established for contractual survey services are expended and further to insure that the number of corners accepted for recordation complies with requirements of the Remonumentation Project Grant.”
3. In RFQ #09-008, Section 10. Evaluation Criteria, page 14, item # 5, has been deleted.
4. In RFQ #09-008, page 16, the Genesee County Bidders Insurance Checklist has been modified by deleting **\$600,000 in aggregate for Medical Malpractice**.

5. In RFQ #09-008, Attachment 3 – PROFESSIONAL SERVICES CONTRACT, Exhibit A, page 56, item #8., should read as follows:

“Completion Date: Work may begin immediately after contract **execution**. All field work must be completed no later than December 10, 2009 and all office activities completed no later than December 20, 2009. Contractor must perform all services in a professional and timely manner acceptable to the **Peer Review Group** and the County Representative to insure that grant funds established for contractual survey services are expended and further to insure that the number of corners accepted for recordation complies with requirements of the Remonumentation Project Grant.”

6. Please see the following questions submitted in response to the above referenced RFQ with corresponding answers:

Q1. Am I correct that price is not an issue, in that the County is telling us they will pay \$1100/corner and there are 84 corners?

A1. Yes.

Q2. How much will "previous experience with Genesee County's Monumentation & Remonumentation Program" count in the evaluation?

A2. The referenced evaluation factor has been deleted.
